That part of the North East fractional quarter of Section 2, Township 40 North, Range 13, East of the Third Principal Meridian lying Southeasterly of Kimball Avenue (McCormick Boulevard), Northeasterly of the center line of Lincoln Avenue and Westerly of the Westerly line of the Sanitary District of Chicago, described as follows: Beginning at a point on the Easterly line of McCormick Boulevard 734.89 feet Northerly of the Center Line of Lincoln Avenue, as Measured along the Easterly line of McCormick Boulevard: Thence Northeasterly along the Easterly line of McCormick Boulevard 108.0 feet to a point of curvature.
