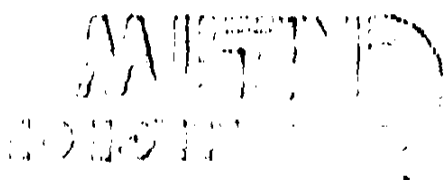

Section Two: By reason thereof, the new corporate boundary of the Village of Crestwood shall extend to the far right-of-way of Turnpike Road bordering upon the territory annexed

Section Three: The Village Clerk shall file a plat of annexation describing said property, together with a duly certified copy of this Ordinance, in the office of the Recorder of Cook County, Illinois.

Section Four: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

the East 1/4 of the West 4/5 of the Southeast 1/4 of Section 4, Township 36 North, Range 13 East of the Third Principal Meridian, except the North 215 feet thereof, and except that part thereof lying South of a line which is 50 feet North of and parallel to a line described as follows: beginning at a point in the West line of said Section 4, said point being 881.13 feet North of the Southwest corner of said Section 4; thence in a general Easterly direction along a straight line which forms an angle of 750-46', measured from North to East, a distance of 1053.00 feet to a point of curve; thence in a general Easterly direction along a curved line tangent to the last described straight line, convex Southerly, having a radius of 20,222.06 feet, a distance of 635.29 feet to a point of tangency; thence in a general Easterly direction along a straight line tangent to the last described curved line, a distance of 758.33 feet to a point of curve; thence in a general Easterly direction along a curved line, convex Southerly, having a radius of 6,740.74 feet, a distance of 609.80 feet to a point of tangency; thence in a general Easterly direction along a straight line tangent to the last described curved line, a distance of 1055.69 feet to a point; thence in a general Easterly direction along a straight line which forms an angle of 180-01' measured from West to East clockwise, a distance of 1353.1 feet to a point in the East line of Section 4 aforesaid, said point being 535 feet South of the Northeast corner of the Southeast 1/4 of Section 4 aforesaid, all in Cook County, Illinois.
