

The Court, being fully advised of the premises and a sufficient showing that immediate and irreparable less will result to the People if notice is given to the Defendant that he will be able to remove from the jurisdiction of the Court, conceal, destroy, or otherwise dispose of property which may be subject to forfeiture under the Narcotics Profit Forfeiture Act, it is hereby ordered:


