**TO HAVE AND TO HOLD** the said premises with all appurtenances upon the trust and for the uses and purposes herein and in said trust agreement set forth:

Full power and authority is hereby granted to said trustee to improve, manage, protect and subdivide said premises or any part thereof, to dedicate parks, streets, highways or alleys and to vessels, any subdivision or part thereof, and to subdivide said property as and when desired, to contract in sell, to grant options to purchase, to sell on any terms, to convey either with or without consideration, to convey said premises or any part thereof to a successor or successors in trust and to grant to such successors or successors in trust all of the title, estate, powers and authorities vested in and retained to dominate, to dedicate, to mortgage, pre-empt or otherwise encumber said property, or any part thereof, to lease said property, or any part thereof, from time to time, in possession or reversion, by leases to commence in present or future, and upon any terms and for any period or periods of time, not exceeding the term of 100 years, and to renew or extend leases upon any terms and for any period or periods of time, not exceeding the term of any such lease, at the terms and provisions thereof at any time or times hereafter, to contract to make leases and to grant options to lease and options to renew leases, and options to purchase any part of the reversion and to contract respecting the manner of fixing the amount of present or future estate in partition, or in exchange said property, or any part thereof, for other real or personal property, to grant easements or charges of any kind, to release, convey or assign any right, title or interest in any part of said appurtenant to said premises or any part thereof, and in deal with said property in every part thereof in all other ways and for such other considerations as it would be lawful for any person owning the same to deal with the same, whether similar to or different from the ways above specified, at any time or times hereafter.

In no case shall any party dealing with said trustee in relation to said premises, or to whom said premises or any part thereof shall be conveyed, contracted in to sell, leased or mortgaged by said trustee, be obliged under the application of any purchase money, rent or money borrowed, or otherwise advanced on said premises, or be obliged to see that the terms of this trust have been complied with, or be obliged to inquire into the ownership or the character of any part of the title thereto, or to be bound by any deed, trust deed, mortgage, lease or other instrument executed by said trustee in relation to said real estate shall be conclusive evidence in favor of every person dealing with or claiming under any such conveyance. In case other instruments than that at the time of the delivery thereof the trust created by this indenture and by said trust agreement was in full force and effect, (a) that such conveyance or other instrument is binding upon all beneficiaries thereunder, (b) that said trustee was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument and (d) if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessor in trust.

And the said grantors do hereby expressly waive, and release, any and all rights or benefits under and by virtue of any and all statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.


