In addition to the agreement and provision of said Mortgage, the undersigned agree as follows:

- 1. Any provisions of said Mortgage which are inconsistent with the provisions of this Rider are hereby amended or negated to the extent necessary to conform said Mortgage to the provisions of this Rider.
- 2. In order to provide for the payment of taxes and other annual charges upon the property securing the indebtedness, Mortgagor shall pay to Mortgagee on the first day of each month commencing on ist day of May 1986 one twelfth of the estimated annual real estate tax bill (based on the then most recent tax bill). Mortgagee shall pay no interest on such funds. Mortgagee shall be responsible for applying those funds to the tax bills thereafter due. Where such funds are insufficient, Mortgagor upon Mortgagee's demand, shall immediater, pay to Mortgagee the balance necessary to pay those tax bills. At Mortgagor's request from time to time, Mortgagee shall provide Mortgagor with evidence that such taxes and insurance have been paid.
- 3. In the event Mortgagor, his heirs, executors or administrators, assign, convey, contract to convey or otherwise dispose of the mortgaged premises or any part thereof without a prior consent in writing of the Mortgagee or in case of Mortgagor's failure to maintain beneficial membership status in good standing with the Mortgagee, Mortgagee may at his discretion, declare the entire indebtedness to be immediately due and payable, without notice to Mortgagors (which is hereby expressly waived by Mortgagors) and upon such occlaration the entire indebtedness shall be immediately due and payable.
- 4. The failure of Mortgagee to exercise Nortgagee's option for acceleration of maturity and/or foreclosure following any default under the Mortgage, or to exercise any other option granted Mortgagee hereunder in any one or more instances, or the acceptance by Mortgagee of rartial payment hereunder shall not constitute a waiver of any such default, except as may be provided by law, nor extend or affect the grace period, if any, but such option shall remain continuously in force.
