# CERTIFICATE OF RELEASE OF TAX LIEN

Under the Release of Lien Provisions of the Illinois Revised Statutes, the Department of Revenue has determined that the following taxpayer is entitled to a Certificate of Release of Tax Lien because the taxpayer has paid the amount of the tax and interest in full and the amount of the tax and interest has been applied to the taxpayer's account.
