

Sec. 6321. Lien For Taxes.

if any person liable to pay any fax neglects or refused o
pay the same after demand, the amount including any lifter
est, additional amount, addition to tax, or assessable penalty,

Sec. 6322, Period of Lien.

Unless, apother date is specifically fixed by law, the Hen Imposed by section 6321 shall arise at the tiefe the excessment is made and shall continue until the liability for the amount so assessed (or a judgment against the taxpeyer arising out of such liability) is satisfied by becomes unenforceable by season of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

- (a) Purchases, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors.— The lien imposed by section 6321 shell not be valid as security interest, Dechanic's Benoi, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.
- (b) Protection for Certain interests Even Though Notice Filed. — Even though notice of a lien imposed by section 6321 has been filed, such tien shell not be valid.
 - (f) Place For Filing Notice; Form.—
- (1) Place For Filing. The notice referred to in subsection (a) shall be filed—
 (b) Under State Laws.—
 - (i) Real Property. in the case of real property, in one pilics within the State (or the county, or other povernmental subdivision), as designated by the laws of such State, in which the property subject to the lien is altusted; and
- with the (ii) Personal Property, In the case of personal property, whether tangible or intengible, in one office within the State for the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the iten is situated;

Sec. 6325. Release Of Lien Or Discharge Of Property.

- (a) Release Of Lien. I Subject to such teglicitions as the Secretary may prescribe, the Secretary may issue a pertificate of release of any lien imposed with respect to any internal revenue tax if
- (1) Liability Satistied or Unantorcoable. The Secretary trads that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become legally unantorceable; or
- (2) Dand Accepted. There is turnished to the Secretary and accepted by him a band that is conditioned upon the payment of the amount assessed, together with all interest in respect thereof, within the time prescribed by taw (including any extension of such time), and that is in accordance with such requirements rotating to totals, condition, and form of the bond and sureties thereon, as may be specified by such regulations.
