MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE (hereinafter referred to as the "Memorandum") dated the day of Porto, 1986, by and between CHICAGO UNION STATION COMPANY, an Illinois corporation (hereinafter referred to as "Lessor"), and CHICAGO TITLE AND TRUST COMPANY, not personally but as Trustee under Trust Agreement dated April 16, 1985, and known as Trust No. 1086781 (hereinafter referred to as "Lessee").

WITNESSETH:

- 1. This document is the memorandum of that certain unrecorded less dated $\Delta pol S$, 1986 (hereinafter referred to as "Lease"), between Lessor and Lessee.
- 2. Pursuant to the Lease, Lessor leased to Lessee certain real estate located in Chicago, Cook County, Illinois, legally described on Exhibit A attached hereto and made a part hereof (hereinafter referred to as "Lessor's Real Estate").
- 3. The term of the Lease is ninety-nine (99) years, which term became effective on October 1, 1985.
- 4. The Lessee is the owner of certain real estate located in Chicago, Cook County, Illinois, legally described on Exhibit B attached hereto and made a part hereof (hereinafter referred to as "Lessee's Real Estate"). In the event Lessee shall be in default under the Lease, Lessor has been granted the right to purchase Lessee's Real Estate under the terms set forth in the Lease.
- 5. The Lease also provides that upon termination of the Lease, Lessor has the option to wither purchase Lessee's Real Estate or to require Lessee to purchase Lessor's Real Estate under the terms set forth in the Lease.
- 6. This Memorandum is not a complete summary of the Lease. The provisions in this Memorandum shall not be used in interpreting the provisions of the Lease. In the event of conflict between this Memorandum and the Lease, the Lease shall control
- 7. It is expressly understood and agreed by and be ween the parties hereto, anything herein to the contrary notwith randing, that each and all of the representations, covenants, undertakings and agreements herein made on the part of Chicago Title and Trust Company, not personally but as Trustee aforesaid while in form purporting to be the representations, covenants, undertakings and agreements of said Trustee are nevertheless each and every one of them, made and intended not as personal representations, covenants, undertakings and agreements by said Trustee or for the purpose or with the intention of binding said Trustee personally but are made and intended for the purpose of binding the trust property, and this instrument is executed and delivered by said Trustee, not in its own right, but solely in the exercise of the powers conferred upon it as such Trustee; and that no personal liability or personal responsibility is assumed by nor shall, at any time, be asserted or enforceable against under said Trust Agreement, on account of this instrument or on account of any representation, covenant, undertaking or agreement of the said Trustee in this instrument contained, either expressed or implied, all such personal liability, if any, being expressly waived and released.
