RESOLUTION BY THE UNIT CHNERS OF SPRING MILL TOWNIONES ASSOCIATION

Annaum to the Illine's Course Not-Lor-Protet Corporation Act and the Bylans of the Spring Mill lownbrook Association, Acticle XIII, Section 1, pursuant to proper notice at a regular meeting of the Board of Directors, the Board of Directors adopts the following resolution:

WEREAS, the Declarations of Spring Creek Homeowners Association Article 1, Section 3 only provides for the formation of the initial Board on the Spring Creek Homeowners Association; and WEREAS, the conditions for the cessation of such initial Board have been met; and

WEREAS. It is the intent of the Spring Crock Homeowners Association <u>Declarations</u> to provide three (3) directors of the respective homeowners' associations elected by each <u>homeowner's</u> association in a munner consistent with the Bylaws; and

WEREAS, Buttercreek Condominium Association has elected its directors to the Spring Creek Homeowners Association Board to the manner provided for within Buttercreek Condominium Association Bylaws;

NOW THEREFORE BE IT LESS AND THAT: The local of Directors of the Spring Mill Townhomes Association hereby amends its Bylaws as provide a method of election of the Spring Mill representatives on the Spring Creek Homeowners Association Board of Directors; and the following amendment to the Bylaws shall appear under Article VI of Pac Bylaws as now Section 12:

RESOLVED: "The Board of Directors of the Spring Mill Townhomes Association shall have the right and power to designate the Spring Mill Townhomes Association representatives to serve on the Spring Creek Tomesmoers Association board of directors from among the members of the Spring Mill Townhomes Association Board; and such representatives will serve At Will of the Spring Mill Townhomes Association Board of Directors. The Spring Mill Board of Directors shall also have the power from time to time to remove without cause its representatives, upon written notice to said representatives, and to designate new representatives to serve in the removed representatives' place. This method of election of representatives to the Spring Creek Homeowners Association board any be amended from time to time by the Spring Mill Townhomes Association Board of Directors. Note: his network the power and right of the Spring Mill Townhomes Association Board of Directors to designate its representatives on the Spring Creek Homeowners association Board of Directors in its sole discretion shall have the power to nominate candidates and call an election among the powers of Spring Mill to designate Spring Mill Townhomes Association representatives to serve on the Spring Creek Homeowners to and of directors."
