1. Page 2, the second covenant of the Mortgagor is amended to read:

That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee, on the first day of each month until the said note is fully paid, the following sums:

- (a) A sum equal to the ground rents, if any, next due, plus the premiums that will next become due and payable on policies of fire and other hazard insurance covering the portgaged property, plus taxes and assessments next due on the mortgaged properly (all as estimated by the Mortgagee) less all sums already paid therefor divided by the number of months to clapse before one month prior to the date when such ground rents, premiums, taxes and assessments will become delinquent, such sums to be held by Mortgagee in trust to pay said ground rents, premiums, taxes and special assessments; and
- (b) All payments inequenced in the two preceding subsections of this paragraph and all payments to be pusely under the note secured bereby shall be added together and the aggregate amount thereof shall be paid by the Mertpagor each month in a single payment to be applied by the Mortgagee to the following items in the order set forth:
 - (f) ground rents; if a y taxes, special assessments, fire, and other hazard instrance premiules.
 - (II) interest on the note secured hereby; and
 - (III) amortization of principa of the said note.
