AGREEMENT FOR ADDITIONAL ADVANCE

AGREEMENT, made March 14, 1986 between Carrie M. Mayes hereinafter referred to as Mortgagors and the Chicago Metropolitan Mutual Assurance Company hereinafter referred to as Company, Witnesseth:

NOW, THEREFORE, the parties hereby agree:

- 1. That said Company shall make such additional advance to said Mortgagors and the Mortgagors agree to repay such advance (in addition to the payments provided in said Note and Trust Deed) in the following manner: \$28.12 on April 1st and \$28.12 on the first day of each and every month thereafter until said additional advance shall have been fully paid; said payments shall include interest at the rate of 11½ % per annum on the unpaid balance calculated in the same manner as is provided in the Note and Trust Deed hereinbefore referred to.
- 2. That such additional advance constitutes an additional inceptedness secured by said Trust Deed and it is hereby agreed that neither the Note, the Trust Deed nor other security given to secure the said Note, shall in anywise be prejudiced by this a greement and that said Note and Trust Deed shall be and remain in full force and effect.
- 3. That the Mortgagors hereby warrant that there are no liens against said premises which remain unsatisfied other than the aforesaid mortgage to said Company.
