AGREEMENT

THIS AGREEMENT made this 8th day of April, 1986, by and between FIRST NATIONAL BANK OF NORTHBROOK, as Trustee under Trust Agreement No. 318 dated _ Feb _ 4 _ 1986_____ hereinafter referred to as "Trustee"; and H & L BUILDERS, INC., an Illinois Corporation, hereinafter referred to as "Developer", and the TOWN OF NORTHFIELD, Cook County, Illinois, a civil Township, hereinafter referred to as "Township".

HITHESSETH:

WHEREAS, the Developer proposes to subdivide a parcel of land hereinafter referred to as the Tract, comprised of the land hereinafter legally described, the legal title to which is held by the Trustee. Said Tract is wholly contained within the Township of Northfield and has been accepted for annexation and for subdivision by the Village of Glenview into a subdivision consisting of two (2) phases having in the aggregate a total of twenty-eight (28) Lots. Phase I consists of Lots 8 through 22 in the proposed subdivision and the balance of the lots comprise Phase II.

LEGAL DESCRIPTION

The North one-half of the South one-half of the East one-half of the East one-half of the North West one-quarter (Except the West 100 feet of the East 150 feet of the South 100 feet of the North 166 feet thereof) of Section 33, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois.

public record their Agreement so that it is binding upon all parties and their successors and assigns.

THEREFORE, in consideration of the mutual covenants contained herein and the facilities to be provided by the Township and the payment to be made by the Developer, it is agreed as follows:

- The Developer does hereby agree to pay to the Township the sum of SIXTY-TWO THOUSAND DOLLARS (\$62,000.00) as follows:
 - (A) The sum of THIRTY-TWO THOUSAND DOLLARS (\$32,000.00) to be paid at the earliest of:
 - 1. Sixty (60) days after the date of this Agreement;
 - 2. Upon the signing, at the request of the Subdivider, of the fifth Metropolitan Sanitary Vistrict's Sewer Permit by the Township for the development of the lots upon the Tract.
 - (B) The payment of THIRTY THOUSAND DOLLARS (\$30,000,00) plus eight percent (25) interest on the unpaid balance commencing from the date of this Agreement to be due no later than April 7, 1887.
- 2. It is agreed that if any lots are sold from Phase II of the Developer's Tract prior to April 7, 1987, then the Developer, or his successors and assigns in interest, shall pay to the Township upon said sale or upon the Township's signing a permit for the Metropolitan Sanitary District for said lot, whichever is earlier, the sum of TWO THOUSAND THREE HUNDRED DOLLARS (\$2,300.00) per lot plus accrued interest thereon. Upon any such payment, the \$30,000.00 sum due on April 7, 1987, shall be reduced by the principal payments made under this provision.
- 3. Upon payment as above provided, the appropriate Lots or Tract shall no longer be subject to the Agreement and upon request, the Township shall provide written releases or termination of this Agreement as appropriate. Upon payment as provided in Paragraph 1-A above, all Phase Lots shall no longer be subject to this Agreement.
