FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR INVERNESS ON THE PONDS TOWNHOME CONDOMINIUM ASSOCIATION

FIRST AMENDMENT TO DECLARATION made and entered into by FIRST ILLINGIS BANK OF WILMETTE, not individually, but as Trustee under Trust Agreement dated the 15th day of April And known as Trust No. TWB-0372 (hereinafter referred to as "Trustee").

WITNESSETH:

WAEREAS, by the Declaration of Condominium Ownership recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 86063691 (the "Declaration"), certain real escale was submitted to the Condominium Property Act of the State of 101 nois (the "Act"), said Condominium being known as Inverness on the Ponds Phase I (the "Condominium");

WHEREAS, the Declaration reserves and grants to the Trustee the right to anney and add to the Parcel and Property (as those terms are defined in the Declaration) and thereby add to the Condominium created by the Declaration all or any portion of the Development Area (as that term is defined in the Declaration); and

WHEREAS, the Trustee is the legal title holder of and now wishes to so annex and add to said Parcel and Property and submit to the provisions of Act as part of the Condominium the following real property (the "Additional Property") described on Schedule 1 attached hereto;

NOW, THEREFORE, FIRST ILLINOIS MANK OF WILMETTE, as Trustee aforesaid and not individually, as the legal title holder of the Additional property, and for the purpose above set forth, hereby declares that the Declaration be and hereby is amended as follows:

- The Additional Property is herety annexed to the Parcel and Property as defined in Article I of the Declaration and, together with all improvements and structures erected, constructed or contained thereon, is hereby subditted to the provisions of the Act as part of the Condominium in accordance with, and shall be deemed to be governed in all relates by, the terms and provisions of the Declaration.
- Exhibit "A" of the Declaration is hereby amended by deleting said Exhibit "A" and substituting Exhibit "A" attached hereto.
- Exhibit "B" of the Declaration is hereby amended by deleting Sheet 1 of said Exhibit "B" and substituting therefor of Exhibit "B-1" attached hereto, and by the Sheet 1 of addition of Sheets 4.5,6.7 out of 7 attached hereto.
- The percentage of ownership in Common Elements appurtenant to each Unit (as that term is defined in the Declaration) is hereby shifted to the respective percentages set forth in Exhibit "C" attached hereto, and Exhibit "C" of the Declaration is hereby amended by deleting said Exhibit "C" and substituting Exhibit "C" attached hereto.
- The additional common elements annexed by this instrument are hereby granted and conveyed to the grantees of all Units, including the grantees of Units heretofore conveyed, all as set forth in the Declaration.

It is expressly understood and agreed by every person, firm, or corporation now or hereafter claiming any interest under this Decliration that FIRST ILLINOIS BANK OF WILMETTE, as Trustee aforespid, and not personally, has joined in the execution of this Sectoration for the sole purpose of subjecting the title holding Interest in the trust estate under said Trust Agreement No. TWB-0372 to the terms of this Declaration; that any and all obligations, duties, covenants, and agreements of every nature herein set furth by FIRST ILLINOIS BANK OF WILMETTE, as Trustee aforesaid, to he kept and performed, are intended to be kept, performed and discharged by the beneficiary under said Trust No. TWB-0372 and that the Trustee has first been supplied with funds required for the purpose. In the event of conflict between the terms of this paragraph and the remainder of the Declaration on any question of apparent liability or obligation resting upon said Trustee, the exculpatory provision hereof shall be controlling.
