Pursuant to Article 6, Section 6.08 of the Declaration, assessments shall be reallocated among all Homesites (including those described in Exhibit "B" hereof) as set forth in Exhibit "D" hereof, hereby superseding Exhibit "F" of the Declaration and Exhibit "D" of Supplement Number 8 recorded December 31, 1985.

Except as herein supplemented, all other provisions of the Declaration shall remain in full force and effect. In the event of any inconsistency between the terms hereof and those of the
