Mortgagor further recognizes that any secondary or junior financing placed upon the Premises, or the beneficial interest of the Mortgagor (a) may divert funds which would otherwise be used to pay the Note secured hereby; (b) could result in acceleration and foreclosure by any such junior encumbrance which would force Mortgagee to take measures and incur expenses to protect its security; (c) would detract from the value of the Premises should Mortgagee come into possession thereof with the intention of selling same; and (d) would impair Mortgagee's right to accept a deed in lieu of foreclosure, as a foreclosure by Mortgagee would be necessary to clear the title to the Premises.

or the grant of a security interest of the title to the Premises or the beneficial interest or power of direction under the Trust; or any transfer or the occurrence of any other transfer, conveyance, hypothecation or contract to do any of same which results in a breach of the Note. Any consent by Mortgagee, or any waiver by Mortgagee of an event of default under this paragraph shall not constitute a consent to, or waiver of any right, remedy or power of Mortgagee upon a subsequent Event of Default under this Paragraph 28. 30. Business Purpose.
