This Memorandum of Agreement (the "Memorandum"; is made and entered into as of the 16 day of Herch, 1986, by and between Norman Hanfling (the "Borrower") and William H. Smith ("Smith") and Alan J. Inhinder ("Inbinder") (Smith and Inbinder are hereinafter collectively referred to as the "Lender").

#### RECITALS

- Borrower and Lender have entered into a certain Loan Agreement of even date herewith pursuant to which Lender has agreed to lend to Borrower the principal amount of One Hundred Fifty Thousand vollars (\$150,000.00) with interest thereon at the rate stated in Borrower's Note (the "Note") of even date herewith (the "Loan") upon the terms and conditions set forth therein (the "Loan Agreement").
- The proceeds of the Loan will enable Borrower to obtain a \$4,600,000 construction loan from First Wisconsin National Bank of Milwaukee or a similar lender (the "Construction Loan") and thereby proceed with his plans to renovate the improvements located on the real estate isnally described on Exhibit A attached hereto (the "Property").
- Borrower and Lender now desire to set forth and place of record certain of their agreements as set forth in the Loan Agreement.

NOW THEREFORE, for and in consideration of the premises, One Dollar (\$1.00) in hand paid and other good and valuable consider in the receipt and sufficiency of which are hereby acknowledged, the parties hereto state as follows:

- The Loan is to be repaid to Lender on or before the earliest to occur of (i) the one hundred twentieth 120th) day immediately subsequent to the date of the Note, (ii) the date on which the first disbursement under the Construction Loan is made, or (iii) the date on which Lender elects, by reason of the occurrence of any Type B Default (as defined in the Loan Agreement) to declare all indebtedness evidenced by the Note immediately due and payable.
- Lender hereby expressly agrees that its rights pursuant to the Loan Agreement and all other documents executed in connection therewith are and shall remain subordinate in all respects to the rights of First National Bank of Lincolnshire pursuant to that certain Promissory Note dated January 18, 1984 in the original principal amount of Three Hundred Twenty-Five Thousand Dollars (\$325,000.00) and all documents executed in connection therewith,
