Parcel 1: The east 40 feet of lot 5 in the Assessor's Division of Lots 1, 2, 7 and 8 in Block 37 in Original Town of Chicago in Section 9, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois.

Parcel 2: The private alley 10 feet in width lying west of and adjoining the 5 foot alley south and adjoining lot 4 and also lying west of and adjoining lots 4, 7, 8 and 1 and east of and adjoining lot 5 in the Assessor's Division of Lots 1, 2, 7 and 8 in Block 37 in Original Town of Chicago in Section 9, Township 39 North, Range 14 East of the Third Principal Meridian, said private alley being parallel to the west line of State Street, 90 feet west of the easterly line of lot 1 and running from Randolph Street, to the 1st alley south of same which runs parallel thereto, in Cook County, Illinois.

Parcel 3: That part of lot 1 in Block 37 in Original Town of Chicago, described as follows: commencing on the south line of Randolph Street, at a point 20 feet east of the east line of private alley established by Joseph Matteson and others and described in agreement recorded October 14, 1812 as document number 10189, in Book 8, Pages 266 and 267; thence east on the south line of Randolph Street, 20 feet; thence south parallel with the east line of said private alley 61 feet 9 inches; thence west parallel with Randolph Street, 20 feet; and thence north to the point of beginning, in Cook County, Illinois.
