TO HAVE AND TO HOLD the above-described premises, with the appurtenances and fritures, unto the said Mortgagee, its successors and assigns, forever, for the purposes and uses herein set 'ort', free from all rights and benefits under and by virtue of the Homestend Exemption Laws of the State of Illino's, which said rights and benefits the said Mortgagor does hereby expressly release and waive.

AND SAID MORTGAGOR covenants and agrees:

- 1. Page 2, the first covenant of the Mortgagor is amended to read: That privilege is reserved to pay the debt, in whole or in part, on any installment due date.
- 2. Page 2, the second covenant of the Mortgagor is amended to read:
  That, together with, and in addition to, the monthly payments of principal and interest
  payable under the terms of the note secured hereby, the Mortgagor will pay to the Mortgagee, on
  the first day of each month until the said note is fully paid, the following sums:
  - (a) A sum equal to the ground rents, if any, next due, plus the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes and assessments next due on the martraged property (all as estimated by the Mortgageo) less all sums already paid therefore divided by the number of months to clapse before one month prior to the date when such ground rents, premiums, taxes and assessments will become delinquent, such sums to be held by Mortgageo in trust to pay said ground rents, premiums, taxes and special assessments; and
