That part of the Northeast Quarter of Section 16, Township 41 North, Range 10, East of the Third Principal Meridian, beginning at a point in the North line of said Section, 640.32 feet West of the Northeast corner of said Section; thence West on the North line of said Section 781.58 feet to the intersection of the center line of Higgins Road; thence Southeasterly along said center line 746.42 feet to a point 737.68 feet Northwesterly of the intersection of said center line of road with the East line of said Section; thence Northerly to the point of beginning (excepting that part lying Southwesterly of a line 94 feet Northeasterly of and parallel with a line running from a point in the North line of the Northeast Quarter of Section 16 aforesaid, 1471.80 feet West of the Northeast corner thereof, to a point in the East line of the Northeast Quarter of said Section 16, which is 540 feet South of the Northeast corner thereof); said parcel being a part of a triangular tract of land lying between the North line of said Section and the center line of Higgins Road, and West of a line drawn from a point in the North line of Section 16 which is 575.4 feet West of the Northeast corner thereof, to a point in the center line of Higgins Road which is 675.68 feet Northwesterly of the East line of Section 16, as measured along the center line of Higgins Road from its intersection with the East line of said Section at a point 512.85 feet South of the Northeast corner of Section 16 aforesaid (excepting highways heretofore dedicated), in Cook County, Illinois.
