of 5131 West Wolfram, Chicago, IL _____, party of the second part.

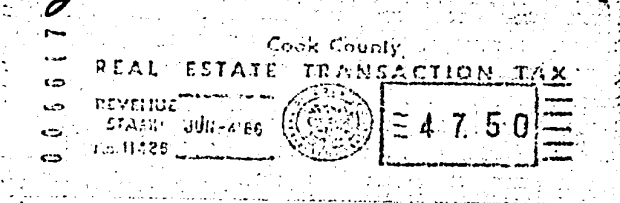
Witnesseth, That said party of the first part in consideration of the sum of Ten & No/100 (\$10.00) _____ Dollars, and other good and valuable

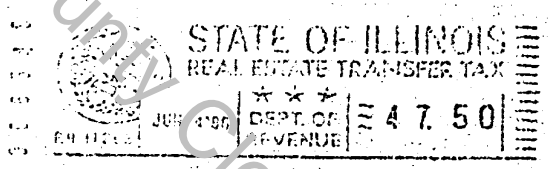
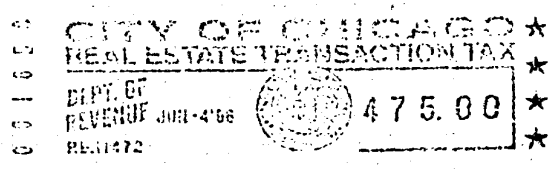

This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in said county remaining unreleased at the date of the delivery hereof.

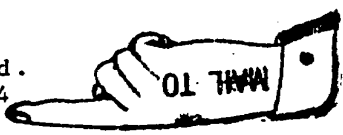
