WHEREAS, First Baptist Church, Wheeling, Illinois, authorized the issuance of a series of bonds, designated as Series Five, dated April 1, 1970, in the aggregate amount of \$165,000, as set forth in a Resolution of the church dated February 22, 1970, which Resolution is recorded in the official records of Cook County, Illinois, as Document 21134832; and,

WHEREAS, such bonds were issued pursuant to and in accordance with the provisions of a Trust Indenture dated May 16, 1970, executed by First Baptist Church, Wheeling, Illinois, and naming Arthur E. Farmer, Carbondale, Illinois, as Trustee; said Trust Indenture being recorded as Document 21 134 832; and,

WHEREAS, the Trust Indenture created a lien against the property of the church, described as follows:

Parcel No. 1: Lot 29 in Anderson's Subdivision of part of the Northeast quarter of the Southwest quarter of Section 10, Township 42, North, Range 11 East of the 3rd Principal Meridian in Cook County, Illinois.

Parcel No. 2: Lots 30 and 31 in Anderson's Subdivision of part of the Northeast quarter of the Southwest quarter of Section 10, Township 42 North, Range 11 East, of the 3rd Principal Meridian in Cook County, Illinois.

AND WHEREAS, said Trust Indenture above described provides as follows: "Insofar as the provisions of the resolution under which previously issued bonds were authorized are not in conflict with the provisions of this Trust Indenture, the Trustee is authorized to act for the benefit of the holders of any of the bonds of Series One, Two, Three and Four, as well as the bonds of Series Five;" the first four bond issues of the church being described as follows:

1. Series One in the principal amount of \$30,000, issued October 1, 1960, in accordance with the terms of a Certified Bond Resolution appearing of record in the Recorder's office of Cook County, Illinois.
2. Series Two in the principal amount of \$19,000 issued June 1, 1962, in accordance with the terms of a Certified Bond Resolution appearing of record in the Recorder's office of Cook County, Illinois as Document No. 18498501.
3. Series Three in the principal amount of \$25,000 issued October 1, 1963, in accordance with the terms of a resolution appearing of record in the Recorder's office of Cook County, Illinois as Document No. 18900825.
4. Series 4 in the principal amount of \$25,000 issued February 1, 1967, in accordance with the terms of a Certified Bond Resolution appearing of record in the Recorder's office of Cook County, Illinois as Document No. 20077658.

AND WHEREAS, in all four of these bond issues the property shown above was shown as the property of the church, against which the bond issues created a lien.

AND WHEREAS, with the exception of Bond 26, Series 5, all bonds from all of said issues have been redeemed, and sufficient funds to cover the redemption of said bond remain on deposit with the Paying Agent Bank, Main Bank, Wheeling.

AND WHEREAS, the church desires that the Trustee of the Series 5 bond issue executed a release of any lien created by the Trust Indenture above described.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

That I, Arthur E. Farmer, Carbondale, Illinois, Trustee, for and in consideration of the premises have RELEASED and by these presents do hereby RELEASE the above described property from all liens securing the bonded indebtedness above described.
