ASSIGNMENT OF SUBLESSOR'S INTEREST IN SUBLEASE AND GUARANTY

This agreement made as of the 9th day of June, 1986 is an Assignment of Sublessor's Interest from CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation, as Trustee under the provisions of a trust agreement dated June 9, 1986 and known as Trust No. 5-68055, As Assignor (hereinafter called "Assignor") to PAG, INC., an Illinois corporation, as Assignee (hereinafter called "Assignee").

- Continental Illinois National Bank and Trust Company of Chicago, a national banking association, as Sublessor, entered into a Sublease dated May 31, 198(("the Sublease") with American National Bank and Trust Company of Chicago, a national banking association, not personally but solely as Trustee under Trust No. 48322, as Sublessee, with respect to Sublesson's undivided 60% interest in the lessee's interest created by lease dated December 26, 1958 between The Prudential Insurance Corporation, as lessor, and 2000 Corporation, an Illinois corporation, as lessee, as amended, with respect to real estate described in Exhibit "A" attached hereto and made a part hereof.
- By instrument dated May 31, 1983 ("the Guaranty"), Jerrold Wexler and Edward Ross guaranteed the obligations of the Sublessee under the Sublease.

- C. The interest of Continental Illinois National Bank and Trust Company, as Sublessor under the Lease and in and to the Guaranty, has been assigned through intermediate assignments to Assignor;
- D. Assignor desires to assign its interest as Sublessor under the Sublease and in and to the Guaranty to Assignee and Assignee desires to receive said assignment of Assignor's interest therain.

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, Chicago Title and Trust Company, as Trustee as aforesaid, as Assignor hereby assigns to PAG, Inc. as Assignee all of its right, title and interest, as Sublessor, under the Sublease and in and to the Guaranty.

In consideration for this Assignment, PAG, Inc. hereby accepts the assignment from Chicago Title and Prost Company, as Trustee as aforesaid of all of the Sublessor's interest under the Sublesse and in and to the Guaranty and agrees to perform all of the covenants and conditions applicable to the Sublessor thereunder.

This instrument is executed by Chicago Title and Trust Company, not personally but solely as Trustee, as aforesaid, in the exercise of the power and authority conferred upon and vested in it as such Trustee. All the terms, provisions, stipulations, covenants and conditions to be performed by Chicago Title and

Trust Company are undertaken by it solely as Trustee, as aforesaid, and not individually and all statements herein made are made on information and belief and are to be construed accordingly, and no personal liability shall be asserted or be enforceable against Chicago Title and Trust Company by reason of any of the terms, provisions, stipulations, covenants and/or statements contained in this instrument.

This Agreement may be executed in multiple counterparts, and all of such counterparts shall constitute one and the same Agreemenc.
