contractor, of Evanston, County of Cook, State of Illinois, 1st National Bank of Winnetka as Trustee u/c/a dated 10/13/84 and known as Trust#L-3376 (and of which affiant believes that L. Thomas Baldwin III is the beneficiary (hereinafter referred to as "owner"), of Winnetka, County of Cook, State of Illinois, and states:

That on November 22, 1985, the owner owned the following described land in the County of Cook, State of Illinois, to-wit:

That part of Lots 4 and 5 in Kloepfer's resubdivision of the North East 1/4 of the South West 1/4 and the South 1/2 of the South East 1/4 of the North West 1/4, and the South West 1/4 of the North West 1/4 of Section 29, Township 42 North, Range 13, East of the Third Principal Meridian, described as follows: beginning at a point in the North Line of said Lot 5, 982 feet West of the North East corner of said Lot 5; thence South along a line, parallel with the West line of said Lots 4 and 5, 269.81 feet to the center of Illinois Road, 176.16 feet; thence North along a line parallel with the West line of said Lots 4 and 5, 293.45 feet to the North line of said Lot 5; thence East along said North line of Lot 5, 174.5 feet to the point of beginning, in Cook County, Illinois. was owner's contractor for the improvement thereof.

That on or about November 22, 1985, said contractor made a subcontract with the claimant, Four Seasons Heating and Air Conditioning Specialists who in turn on November 22, 1985 made a subcontract with claimant to provide labor and materials for the ventilating system

for and in said improvement, and that on March 21, 1986, the claimant completed thereunder all required by said contract to be done.

That said owner, or the agent, architect or superintendent of owner (a) cannot, upon reasonable diligence, be found in said County, or (b) do not reside in said County.

That said contractor is entitled to credits on account thereof as follows: 1,700.00

leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of SEVEN THOUSAND FOUR HUNDRED SIXTY NINE AND 20/100 (\$7,469.20) Dollars, for which, with interest,

the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
