THIS INDENTURE made June 14 19 86, between Roger G. Williams
and Katherine L. Williams, his wife
HERITAGE BANK OF SCHAUMBURG

an Illinois corporation doing business in SCHAUMBURG Illinois, herein referred to as Trustee, witnesseth:
THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the Installment Note herein-after described, said legal holder or holders being herein referred to as Holders of this Note, in the principal sum of EIGHTEEN THOUSAND EIGHT HUNDRED TWENTY-THREE AND 66/100----- Dollars, evidenced by one certain Installment Note of the Mortgagors of even date herewith, made payable to BEARER HERITAGE BANK OF SCHAUMBURG, OR ITS ASSIGNS

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest on the balance of principal remaining from time to time unpaid at the rate of Prime + 2% per annum in installments as follows:

Dollars on the 20th day of July 1986 and

FOUR HUNDRED AND NINE DOLLARS AND 22/100-----
Dollars on the 20th day of each month thereafter until said note is fully paid except the final payment of principal and interest, if not sooner paid, shall be due on the 20th day of June, 1991

All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each installment unless paid when due shall bear interest at the rate of maximum allowed by law per annum, and all of said principal and interest being made payable at such banking house or trust company in Schaumburg Illinois as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of Heritage

Bank of Schaumburg in said City.

NOW, THEREFORE, the Mortgagors to secure payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the COUNTY OF Cook AND STATE OF ILLINOIS.
