or its agents, due or to become due, or that may hereafter be contracted, and also to the payment of all expenses and the care and management of said premises, including taxes and assessments, and the interest on encumbrances, if any, which may be in its judgement deemed proper and advisable.

This instrument is given to secure payment of the principal sum and interest, of or upon a certain loan for \$375,000.00 dollars secured by a Mortgage or Trust Deed dated the 30th day of May, 1986, conveying and mortgaging the real estate and premises hereinabove described to University Savings and Loan Association and this instrument shall remain in full force and effect until said loan and the interest thereon and all other costs and charges which may have accrued under said Mortgage or Trust Deed have fully been paid.
