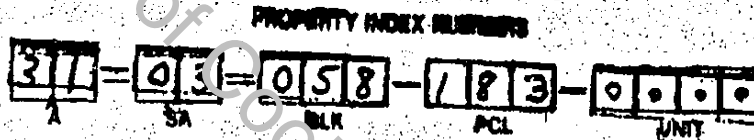

## RIDER LEGAL DESCRIPTION

Beginning at the Northwest corner of the aforesaid Parcel 58; Thence South along the West line of said Parcel 29.06 feet to an intersection with the center line of a party wall extended West; Thence East at right angles to the last described course along an extension of and the center line of a party wall for a distance of 51.27 feet; Thence North at right angles to the last described course for 0.21 feet; Thence East at right angles to the last described course for 22.43 feet to a point in the East line of the aforesaid parcel 58; Thence North along the East line of said parcel for 28.85 feet to the Northeast corner of said Parcel 58; Thence West along the North line of the aforesaid Parcel for 64 feet to the place of beginning.
