#### MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE, dated as of the <u>26th</u> day of <u>June</u>, 1985 by and between LaSALLE PROPERTIES, a joint venture, ("Landlord") and BRITTANY, LTD., an Illinois corporation ("Tenant"),

#### WITNESSETH: THAT
