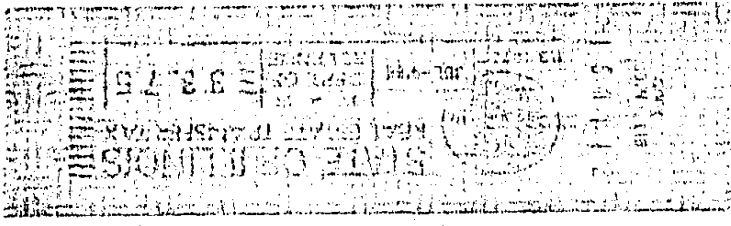
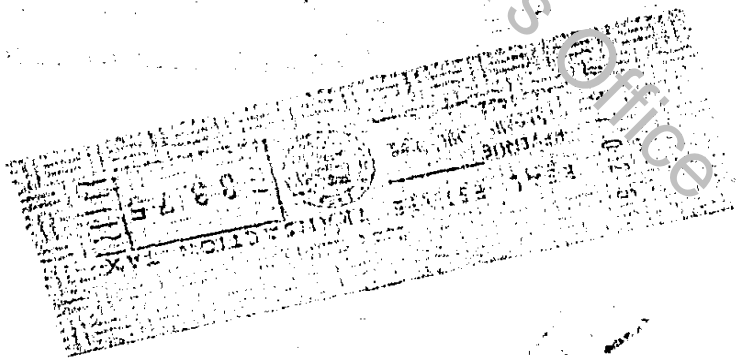

LEGAL DESCRIPTION
