



Abstract of the invention  
The present invention  
relates to a method  
of determining the  
optimal conditions  
for the growth of  
microorganisms in  
liquid media. The  
method involves the  
measurement of the  
optical density of  
the culture at  
regular intervals  
and the plotting of  
the results on a  
semi-logarithmic  
graph. The point  
at which the curve  
begins to level off  
is taken as the  
optimal growth  
condition. This  
method is applicable  
to a wide variety  
of microorganisms  
and media.
