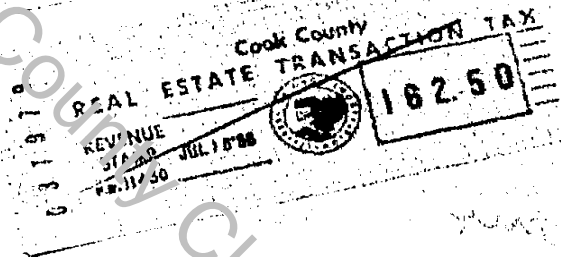
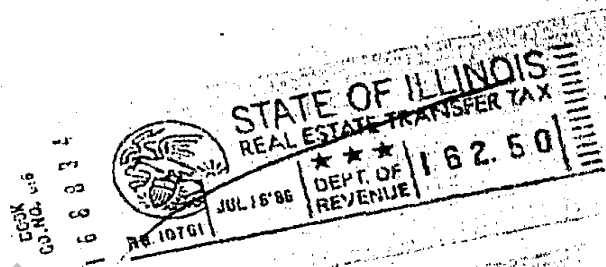

LEGAL DESCRIPTION

PARCEL II
