MEMORANDUM OF SUBLEASE

This is the Memorandum dated April 25, 1986 of that certain unrecorded Sublease Agreement dated April 25, 1986 ("Sublease"), by and between 223 West Ontario Corporation, an Illinois corporation ("Lessor"), and 223 W. Ontario Associates, Ltd., an Illinois limited partnership ("Lessee").

WITNESSETH:

Lessor entered into a Lease Agreement dated November 5, 1985 (the "Underlying Lease") as lessee, with Faucher Bros. Cartage, Inc., as lessor (the "Underlying Lessor"), for the property legally described in Exhibit & (the "Property").

Lessor desires to sublease to Lessee a portion of the Property leased to Lessor by the Under ying Lessor and Lessee desires to sublease a portion of the Property from Lessor.

For good and valuable consideration, Lessor subleases the Property, excluding therefrom the right to use, puild in, dedicate, lease, grant a license of or easement over or develop any space in or any rights associated with the air rights above the existing buildings on the Property, which rights are reserved to Lessor, together with all improvements, to Lessee, and Lessee subleases the Property with the exclusion stated above from Lessor, for the term and under the provisions contained in the Sublease, which Sublease is incorporated in this Memorandum by this reference.

The term of the Sublease is twenty (20) years commencing January 27, 1986 and ending on the last day of the two hundred fortieth (240) complete calendar month following commencement, unless sooner terminated, as stated in the Sublease.

Lessee is granted four (4) options of renewal of the Sublease for a term of five (5) years each; provided, Lessee may only exercise each such renewal option if it is not in default of the Sublease.

If the Underlying Lease is cancelled or terminated in accordance with its terms or by the surrender thereof, whether voluntary, involuntary or by operation of law, the Sublease shall not be cancelled or terminated but Lessee shall make full and complete attornment to the Underlying Lessor for the balance of the term of the Sublease with the same force and effect as though the Sublease were originally made directly from the Underlying Lessor to Lessee.

This Memorandum is not a complete summary of the Sublease. Provisions in the Memorandum shall not be used in interpreting the Sublease provisions. In the event of conflict between the Memorandum and the Sublease, the Sublease shall control.
