THIS INDENTURE, made June 9,

1986, between JOSEPH RIMKUS

herein referred to as "Mortgagors," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of Sixty-Two Thousand Five Hundred Fifty and no/100 (\$62,550.00) —

evidenced by one certain Instalment Note of the Mortgagors of even date herewith, made payable to THE ORDER OF ~~MIRIAM~~ MIRIAM RICHMOND — Dollars,

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest from June 11, 1986 on the balance of principal remaining from time to time unpaid at the rate of 10 per cent per annum in instalments (including principal and interest) as follows: Five Hundred Forty-six and 31/100 (\$546.31) —

Dollars or more on the 11th day of July, 1986 and Five Hundred Forty-six and 31/100 (\$546.31) — Dollars or more on the 11th day of each month thereafter until said note is fully paid except that the final payment of principal and interest, if not sooner paid, shall be due on the 11th day of June, 1987. All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each instalment unless paid when due shall bear interest at the rate of 13 per annum, and all said principal and interest being made payable at such banking house or trust company in Skokie, Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of MIRIAM RICHMOND, 4241 W. Keeney, in said City. NO MONTHLY PAYMENTS SHALL BE DUE UNTIL JUNE 11, 1987.

NOW, THEREFORE, the Mortgagors to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the city of Chicago, COUNTY OF Cook AND STATE OF ILLINOIS, to wit:

Lot 12 in Block 1 in Goudy's Subdivision of that part lying West of The Chicago, Evanston and Lake Superior Railway of the South East Quarter of the South West Quarter of Section 20, Township 40 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.
