Section 221 of the Real Property Law expressly provides who may exercise the certificate of discharge in specific cases and also provides, among other things, that (1) no certificate shall purport to discharge more than one mortgage, except that multiple certificates effected by successive acts of conveyance, creation, modification or correction may be executed to give certificate of the instrument creating the original mortgage, provided that (2) if the mortgage has been discharged, in whole or in part, the certificate shall not purport to discharge such amount in the character of a part of the principal or personal property bearing the certificate, (3) the names of the creditor and debtor, of the instrument affected, and (4) if the instrument has been recorded, the book and page where it has been recorded, or the serial number of such record. If the instrument is being recorded simultaneously with the certificate of discharge, the certificate of discharge shall be used, and (5) if the mortgage has not been discharged of record, the certificate shall be issued (a) if the mortgage is held by an attorney, including an executor or administrator, the attorney of discharge shall recite the name of the attorney and the name of the grantee(s) to whom the attorney was made or in whom the title or discharge was vested.
