  - (I) ground rents if any, taxes, special assessments, fire, and other hazard insurance premiums;
  - (II) interest on the note secured hereby; and

Any deficiency in the amount of any such aggregate monthly payment shall, unless made good by the Hortzagor prior to the due date of the next such payment, constitute an event of default under this mortgage.
