Article 5. The purposes for which the corporation is organized are: To maintain, operate and manage condominium residential buildings, and other improvements located at 8154-60 West 168th Place in Tinley Park, Illinois. The members of the property known as Camco Condominiums located at 8154-60 West 168th Place in Tinley Park, Illinois, in accordance with the respective percentages of ownership in the Common Elements of the Property owned by the respective Unit Owners, as said terms are defined in the Declaration of Condominium Ownership and the Bylaws for Camco Condominium Association executed by Capital Bank and Trust Company in Trustee under Trust Agreement dated January 10, 1986 and known as Trust Number 998 which Declaration will be recorded in the Office of the Recorder of Deeds of Cook County.

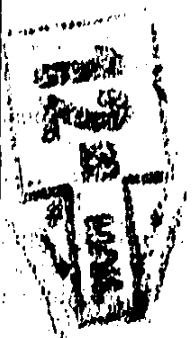
