PREMISES MORTGAGEE'S AGREEMENT

THIS AGREEMENT ("Agreement") is made and entered into as of the 30th day of December, 1985, by the undersigned (the "Premises Mortgagee") in favor of FIRST WISCONSIN LEASING CORPORATION, a Wisconsin corporation (the "Equipment Owner") and CITICORP INDUSTRIAL CREDIT, INC. (the "Equipment Pledgee"; the Equipment Owner and the Equipment Pledgee are hereinafter sometimes collectively called the "Beneficiaries");

W I T N E S S E T H:

WHEREAS, Premises Mortgagee is the holder or beneficiary under a mortgage, deed of trust or similar instrument conveying to it or for its benefit an interest in improved real property located at 11800 Southwest Highway, Palos Heights, Cook County, Illinois, being more particularly described as Lots 3, 4 and 5 in Einoders Southwest Highway Subdivision, being a subdivision of that part of the West 1/2 of the Southwest 1/4 of Section 24, Township 37 North, Range 12 East of the Third Principal Meridian in Cook County, Illinois (the "Premises"); and

WHEREAS, it is the understanding and belief of the Beneficiaries that High Technology, Inc., an Illinois corporation (the "Lessee") is a lessee or sub-lessee of the Premises and has placed on the Premises or from time to time hereafter may place on the Premises certain equipment, including, but not limited to, the equipment described on Exhibit "A" attached hereto and by reference made part hereof (all of such equipment, including, but not limited to, the equipment specified in Exhibit "A" hereto, is hereinafter called the "Equipment"); and

WHEREAS, Equipment Owner is the owner of such Equipment and Equipment Pledgee has been granted a security interest in such Equipment by Equipment Owner; and

WHEREAS, Lessee has requested that Premises Mortgagee execute this Agreement in favor of Beneficiaries, and Premises Mortgagee has agreed to do so with the understanding that Beneficiaries will rely hereon in undertaking certain transactions between and among themselves and Lessee;

NOW, THEREFORE, for \$10.00 and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Premises Mortgagee agrees as follows:

1. The right, title and interest, legal and equitable, of each Beneficiary in and to the Equipment shall be superior to any right, claim or interest which the Premises Mortgagee now or hereafter may have therein, and Premises Mortgagee will not assert against any of the Equipment any right, claim or interest, all of which it hereby postpones in favor of Beneficiaries for the term of this Agreement.

2. The Equipment shall remain personal property notwithstanding the manner of its installation in the Premises.

3. Either Beneficiary may enter onto the Premises in order to remove any Equipment therefrom, so long as such Beneficiary repairs any damage to the Premises caused by such removal.

4. This Agreement shall remain in full force and effect so long as Lessee is a lessee or sub-lessee of the Premises or has any Equipment thereon unless and until the Premises Mortgagee receives written notice from each of the Beneficiaries that their respective interests in the Equipment have been terminated.

5. The provisions of this Agreement may not be modified or terminated orally, and shall be binding upon the successors, assigns and personal representatives of Premises Mortgagee, and upon any successor owner or transferee of the Premises, and shall inure to the benefit of the successors and assigns of each Beneficiary.

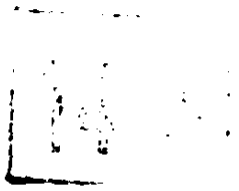

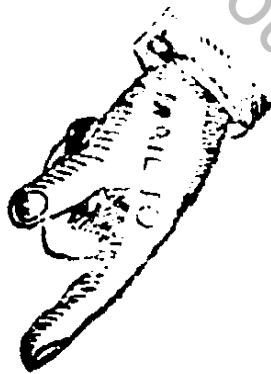
