Unit No. 1 delineated on a survey of Lots 1,2,3,4,5,6,7,8,9,10,11,12,13,14, 15,16,73,74,75,76,77,78,79,80,81,82,83,84,85,86, 87,88, 145 and 151 in Elk Grove Estate Townhome Condominium Parcel 'E', being a subdivision of the Southwest quarter of Section 29 and part of the Northwest quarter of Section 32, Township 41 North, Range 11 East of the Third Principal Meridian, according to the plat thereof recorded September 23, 1971 as document no. 21636091, which survey is attached as Exhibit 'A' to declaration of Condominium Ownership made by Vale Development Company, recorded in the Office of the Recorder of Deeds of Cook County, Illinois as document no. 21673693, and amended by document 21759375; together with a percentage of the Common Elements appurtenant to said Unit, as set forth in said declaration, as amended from time to time, which percentage shall automatically change in accordance with amended declaration as same are filed of record pursuant to said declaration, and together with additional common elements, as such amended declaration are filed of record, in the percentages set forth in such amended declaration, which percentages shall automatically be deemed to be conveyed effective on the recording of each such amended declaration as though conveyed hereby; together with an exclusive easement for parking purposes in and over Lot 76, as defined and set forth in said declaration and survey in Cook County, Illinois.
