Legal Description:

That part of the East 1/2 of the Southeast 1/4 of Section 18, Township 42 North, Range 11 East of the Third Principal Meridian, lying South of the center line of Rand Road, described as follows:

Commencing at a point in the center line of Rand Road that is 154.50 feet Northwesterly of the intersection of the center line of said road with the East line of said Section 18; thence Northwesterly along the center line of said road 100.00 feet; thence Southwesterly 615.56 feet to a point that is 718.00 feet East of the West line and 1830.56 feet North of the South line of said East 1/2 of the Southeast 1/4 of Section 18; thence South parallel to the West line of said East 1/2 of the Southeast 1/4 of Section 18, 149.67 feet; thence Northeasterly 726.92 feet to point of beginning.
