EXTENSION AGREEMENT

THIS INDENTURE, made this 26th day of July, A.D. 1986, by and between Louis E. Siciliano, hereinafter known as Mortgagors, and Heritage/Glenwood Bank, hereinafter known as Mortgagee.

AND WHEREAS, the said Mortgagors have heretofore executed a certain Trust Deed and Note in the principal amount of THIRTY THOUSAND AND 00/100 DOLLARS----- (\$ 30,000.00) to Heritage Glenwood Bank, Mortgagee, dated the 27th day of January, 1983 recorded, registered in the Office of the Recorded Registrar of Cook County, Illinois as Document No. 26527226 and secured by the Real Estate hereinbefore described.

NOW THEREFORE, the Mortgagors and the Mortgagee agree that the time of payment of the said principal amount of THIRTY THOUSAND AND 00/100 (\$ 30,000.00) DOLLARS, with interest at the rate of 11 per cent per annum on the unpaid balance until paid, as provided in said Trust Deed and Note, is hereby changed as follows:

THE PRINCIPAL SUM OF TWENTY-SEVEN THOUSAND FIVE HUNDRED AND 00/100 (\$27,500.00) PLUS INTEREST AT THE RATE OF PRIME + 1.00% FLOATING IS DUE AND PAYABLE ON JANUARY 26, 1987.

AND THE said Mortgagors and Mortgagee further agree that all of the provisions of the said Trust Deed and Note shall remain in full force and effect except as herein expressly modified.
