MORTGAGE

THIS MORTGAGE is made this 20th day of November 1976, between the Mortgagor, Hannelore Heller, A. Spinster, (herein "Borrower"), and the Mortgagee, NILES SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of Illinois, whose address is 7077 W. 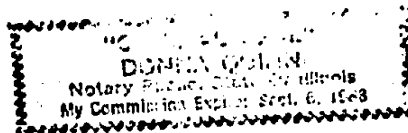
