THIS MORTGAGE is made this 28th day of April 1981, between the Mortgagor, Leonard F. 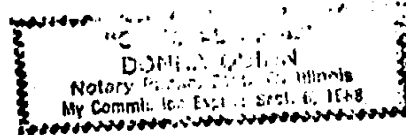
