Notwithstanding any other provision of this Declaration and Bylaws, the Developer reserves and shall have the right at any time and from time to time to record a Special Amendment to this Declaration and hylaws to (i) conform this Declaration with the requirements of the Illinois Condominium Property Act or any Village of Orland Park Condominium Ordinance or the requirements of the Federal National Mortgage Association, the Government National Mortgage Association, the Federal Home Loan Mortgage Corporation, the Department of Housing & Urban Development, the Federal Housing Association, the Veteran's Administration, or any other governmental agency or any other public, quasi-public or private entity which performs (or may in the future perform) functions similar to those currently performed by such entities, (ii) to induce any such agencies or entities to make, purchase, sell, insure, or guarantee first mortgages covering Units, or (iii) to correct clerical or typographical errors in this Declaration, Bylaws, or any exhibit hereto or amendment thereto. In furtherance of the folegoing, each Unit Owner and each holder of a mortgage, trust deed, or lien affecting any Unit and each Person having any other interest in the Property hereby grants to the Developer an irrevocable power of attorney coupled with an interest on behalf of each Unic Owner and each such holder or Person to make, sign and record on behalf of each Unit Owner and each such holder or Person any amendment described in this paragraph. Each deed, mortgage, trust deed, other evidence of obligation or other instrument affecting a Unit or the Property and the acceptance of any such instrument shall be deemed to be a grant and acknowledgement of, and a consent to the reservation of the aforedescribed power of attorney to the Psycloper, to make, sign and record on behalf of each of the Unit Owners, holders and Persons described in the paragraph any amendment described in this paragraph. The power of attorney described in this paragraph shall terminate ten (10) years from the date of recording of this Declaration and By-Laws.
