of the Northeast one-quarter of Section 4, Township 39 North, Range 14 East of the
Third PM A/K/A: 17-04-254-016

James Miller was owner's contractor for
the improvement thereof. That on June 3 1986, said contract-
or made a subcontract with the claimant to provide tile
for and in said improvement, and that on June 3,
1986, the claimant completed thereunder all that was required to
be done by said contract. That at the special instance and re-
quest of said contractor the claimant furnished extra and additional
materials at and extra and additional labor on said premises of the
value of \$ NONE, and completed same on 19 .
That said contractor is entitled to credits of account thereof as
follows: NONE, leaving
due unpaid and owing to the claimant, after allowing all credits, the
sum of One Thousand Thirty-eight and 17/100ths. (\$1,038.17)
Dollars, for which, with interest, the claimant claims a lien on said
land and improvements, and on the moneys or other considerations due or
to become due from the owner under said contract against said contractor
and owner.

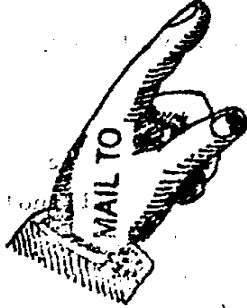
