THIS TRUST DEED, made August 25, 1986, between Michael R. Hall and Marcia L. Hall, his wife, herein referred to as "Mortgagors," and Edward P. Cremarius of Palatine Cook County, Illinois, herein referred to as TRUSTEE, witnesseth THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Promissory Note (herein called "Note") hereinmatter described, said legal holder or holders being herein referred to as Holders of the Note evidenced by one certain Promissory Note of the Mortgagors of even date herewith, made payable as stated therein and delivered, in and by which said Note the Mortgagors promise to pay an Amount Financed of FIVE THOUSAND THREE HUNDRED FIFTY-ONE and 15/100 Dollars with interest thereon, payable in installments as follows: ONE HUNDRED SIXTY-FIVE and 62/100 Dollars or more on the 1st day of October, 1986, and ONE HUNDRED SIXTY and no/100 Dollars or more on the same day of each month thereafter, ~~XXXXX~~ until said Agreement is fully paid and except that the final payment, if not sooner paid, shall be due on the 1st day of September, 1990

NOW, THEREFORE, the Mortgagors to secure the payment of the said sum of money in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in full paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the COUNTY OF COOK AND STATE OF ILLINOIS, to wit:

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.
