

TRÚSTEE'S DEED



WITNESSETH, that Grantor, in consideration of the sum of Ten Dollars (\$10.00), 7 and other good and valuable considerations in hand paid, does hereby convey and quitclaim unto the Grantee, not as Tenants in Common but as Joint Tenants, the followings described real estate, situated in Cook County, Illinios, together with the tenes and appurtenances thereunto belonging:

Unit Number 6-1 in Fieldcrest Condominiums, as delineated on a survey of the following described real estate:

Various Lots in Crestwood Valley Unit Numbers 1, 2, and 3, all being a Resubdivision of Lots 21 to 23 in Arthur T. McIntosh and Company's Cicero Avenue Farms, being a Subdivision of part of the South 2 of 'n' South East 2 of Section 33, Township 37 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois,

which survey is attached as Exhibit "A" to the Declaration of Condominium recorded as Document 85 084 098, and as amended, together with its undivided percentage interest in the common elements in Cook County, Illinois.

THE TENANT, IF ANY, OF THE UNIT CONVEYED HEREBY, HAS EITHER WAIVED OR HAS FAILED TO EXERCISE ITS RIGHT OF FIRST REFUSAL TO PURCHASE SAID UNIT OR HAD NO SUCH RIGHT OF FIRST REFUSAL PURSUANT TO THE PROVISIONS OF THE ILLINOIS CONDOMINIUM PROPERTY ACT.
