THIS INDENTURE, made August 27, 1986, between AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, u/t/a dated April 25, 1986 and known as Trust Number 06926703, a corporation organized under the laws of Illinois, herein referred to as "Mortgagor," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

and delivered, in and by which said Note the Mortgagor promises to pay the said principal sum and interest from August 28, 1986 on the balance of principal remaining from time to time unpaid at the rate of prime plus two (2 per cent per annum in instalments (including principal and interest) as follows: payable upon demand at any time.

Dollars or more on the day of each thereafter until said note is fully paid except that the final payment of principal and interest, if not sooner paid shall be due on the day of 19. All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each instalment unless paid when due shall bear interest at the rate of prime plus five (5) per cent per annum, and all of said principal and interest being made payable at such banking house or trust company in Chicago, Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of The Commercial Bank of Korea, Ltd., Chicago Branch, 230 W. Monroe Street, Suite 1400, Chicago, Illinois 60606 in said City.

NOW, THEREFORE, the Mortgagor to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagor to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, does by these presents CONVEY and MORTGAGE unto the Trustee, its successors and assigns, the following described Real Estate and all of its estate, right, title and interest therein, situated, lying and being in the City of Chicago, COUNTY OF COOK AND STATE OF ILLINOIS.
