heirs, legal representatives and assigns, all the right, title, interest, claim or demand whatsoever it may have acquired in, through or by a certain Trust Deed, bearing date the 18th day of August 1981, and recorded in the Recorder's Office of Cook County, in the State of Illinois, in book 1 of records, on page 26059030, to the premises theremore described, situated in the County of Cook, State of Illinois, as follows, to wit:

That part of the West Half of Section 15, township 42 North, Range 9, East of the Third Principal Meridian, described as follows: Commencing at a point on the West line of the Southwest Quarter of the Northwest quarter of said section 15, 97.53 feet North of the Southwest corner of the said Southwest quarter of the Northwest quarter; thence North on the West line of said Southwest quarter of the Northwest quarter, a distance of 204.98 feet; thence on a $62^{\circ}15' 30''$ angle to the right of the last described course extended, a distance of 307.17 feet for the place of beginning of this description; thence continuing North-easterly on last described course extended, a distance of 290.0 feet; thence Westerly on a $130^{\circ}44'$ angle to the right of the last described course, a distance of 205.0 feet; thence Southwesterly on a $300^{\circ}46' 15''$ angle to the left of the last described course extended, a distance of 102.0 feet to the place of beginning, all in Cook County, Illinois.
