ORDINANCE NO. 1011 (1986) VILLAGE OF CRESTWOOD

AN ORDINANCE ANNEXING
Lots 2, 3, and 4 in Arthur T. McIntosh and Company's Cicero

of the Southeast One-Quarter of Section 33, Township 37
North, Range 13 East of the Third Principal Meridian, in
Cook County, Illinois
