ORDINANCE NO. 1011 (1986) VILLAGE OF CRESTWOOD

AN ORDINANCE ANNEXING

Lots 2, 3, and 4 in Arthur T. McIntosh and Company's Cicero Avenue Farms, a subdivision of part of the South One-Half of the Southeast One-Quarter of Section 33, Township 37 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois

WHEREAS, State Bank of Hammond, as trustee pursuant to its trust agreement numbered "2", having filed, with the Crestwood Village Clerk, a petition requesting annexation to the Village of Crestwood of the territory legally described as:

Lots 2, 3, and 4 in Arthur T. McIntosh and Company's Cicero Avenue Farms, a subdivision of part of the South One-Half of the Southeast One-Quarter of Section 33, Township 37 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois; and

WHEREAS, as stated in said petition, the Village Board finding that (1) State Bank of Hammond, as trustee aforesaid, is the owner of record of all land within such territory, (2) there are no electors residing therein on said territory, (3) said described territory is not within the corporate limits of any municipality, and (4) said territory is contiguous to the Village of Crestwood at this time;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Crestwood:

Section One: That the territory legally described as: Lots 2, 3, and 4 in Arthur T. McIntosh and Company's Cicero Avenue Farms, a subdivision of part of the South One-Half of the Southeast One-Quarter of Section 33, Township 37 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois,

be and the same is hereby annexed to and made a part of the Village of Crestwood, and shall be a part of the Village of Crestwood and all Ordinances of the Village of Crestwood shall be in full force and effect therein.

Section Two: By reason thereof, the new corporate boundary of the Village of Crestwood shall extend to the far right-of-way of Cicero Avenue, Cal-Sag Road (Illinois Route Number 83), and 135th Street as bordering upon the territory annexed.

Section Three: That the Village Clerk file a plat of annexation describing said property, together with a duly certified copy of this Ordinance, in the office of the Recorder of Cook County, Illinois.

Section Four: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
