THIS SIXTH AMENDMENT TO DECLARATION is made and entered into by Kimball Hill, Inc., as sole general partner on behalf of LAKE ARLINGTON TOWNE HOUSING PARTNERSHIP, an Illinois limited partnership, and LAKE ARLINGTON TOWNE COUNTRY HOMES PARTNERSHIP, an Illinois limited partnership, (collectively referred to as "Declarant").

NOW THEREFORM, Declarant as the legal title holder of the Property, and for tre purposes above set forth, hereby declares that the Declaration be and hereby is amended as follows:

- The Additional Fromerty is hereby annexed to the lphaParcel and Property as defined in Article 1 of the act as part of and is hereby submitted to the provisions of the Act as part of and shall be deemed to be governed in all respects, by the terms and provisions of the Declaration.
- It is understood that each Unit in the Property consists of the space enclosed or bound by the horizontal and vertical planes set forth in the delineation thereof in Exhibit The legal description of each such Unit shall consist of the identifying number for such Unit as shown in Exhibit C. C of the Declaration is hereby amended by the addition of Exhibit C attached hereto.
- Exhibit D attached to the Declaration is hereby amended and superseded in its entirety by Exhibit D attached hereto, and respective percentages of ownership in the Common Elements appurtenant to the each Unit described in the said Exhibit D prior to this amendment are hereby reduced to the respective percentages set forth in Exhibit D, as hereby amended.
- The additional Common Elements are hereby granted and conveyed to the Grantees of the Units heretofore conveyed, all as set forth in the Declaration.
- Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
